BOARD OF TRUSTEES MEETING

September 20, 2022

The budget hearing meeting of the Lanesville Community School Board of Trustees was held on September 20, 2022 at the high school cafeteria, 2725 Crestview Avenue, NE, Lanesville Indiana. The meeting was called to order at 5:31 p.m. by board president, Sharon Rothrock. Board members who were present at the meeting were as follows:

Budget hearing

Sharon Rothrock called the budget hearing to order at 5.01 p.m. Mr. Morris reminded the board that the budget process contains the operations fund, the capital projects fund, the bus replacement fund and the debt service fund. We will be discussing the capital projects fund and the bus replacement fund.

Bus Replacement fund

Currently the school corporation owns 3 mid busses and 5 full size busses. Mr. Morris stated that one full size bus may need to be purchased in 2022-2023 as a back-up. The budget allows for \$140,000 for bus replacement. The bus replacement fund also covers school bus driver contracts.

Capital Projects

Capital projects funds support professional services, bonding requirements, utilities, building repairs, purchasing new equipment, paving the parking lot, lighting upgrades plumbing issues, maintenance and renovations of the building and grounds. The capital projects fund is supported by local tax dollars.

Sharon Rothrock made the motion to close the budget hearing. Ron Wolfe seconded the motion. Motion passed 3-0. Meeting adjourned at 6:43.

Regular meeting

Sharon Rothrock called the meeting to order at 6:44 p.m.

Jeff Smitley, Elementary Principal, presented the elementary school report.

Mr. Smitley stated that they have started a Soaring Eagle awards program. This is to promote good behavior.

Mr. Smitley said that they have a student of the month club. He said that each month 17 children will be recognized.

Mr. Smitley said the Elementary School is gearing up for intercession and will follow up with fall break.

Dr. Apple, High School Principal, presented the high school report.

Lanesville Jr.-Sr. High School had 32 students volunteer during Heritage Weekend and accumulated over 200 hours of volunteer work for the festival.

Lanesville had 4 students recognized from this past year by College Board for winning the National Rural and Small Town Award.
